Special Olympics New Hampshire provides statewide sports competitions for athletes and unified partners throughout the year. Activities include State Winter Games serving more than 200 participants; basketball programming for 500 participants through two assessment events and the State Basketball Tournament; three regional competitions leading up to the annual State Summer Games; and State Summer Games that engages over 600 participants across multiple sports. Additional state tournaments serve athletes in softball, golf, tenpin and candlepin bowling. The organization also selects and trains a delegation of 40 athletes and unified partners (Team New Hampshire) to compete at the USA Games.

Special Olympics New Hampshire supports local sports programs, which are teams that train and compete in competitions and may also offer Young Athletes programming (a sport and play program for young children) in their regions. Unified Champion School programs are offered in more than 100 schools, empowering students to foster inclusive school environments for youth with and without intellectual disabilities. Athlete Leadership programming provides training in public speaking and leadership development. The organization also offers fitness initiatives to promote healthy lifestyles and provides Healthy Athletes programs that deliver critical health screenings and education to participating athletes.

Special Olympics New Hampshire provides advanced public awareness efforts to educate communities across the state about the abilities, accomplishments, and potential of individuals with intellectual disabilities.
